1. Requirements concerning textiles / gloves / shoes

To meet the legal demands concerning the labelling of textile products the requirements below are imperative.

2. Labels to tag fabrics in the case of textiles:

- All items of clothing must be labelled with a sewn-in label/tag.
- All textiles must be labelled with the conventional care labels / washing instructions.
- All certified textiles that are in line with DIN / EN standards must bear a label showing the numbered standards and pictograms.
- For products with a "TÜV" label [German technical inspection association] / CE marking, a CE declaration of conformity or copy of the "TÜV" documents are required for Conrad's files.
- All information must be printed clearly on a label. With textiles, the labels are usually sewn either onto the lower inside seam on the right-hand side, onto the middle of the inside collar at the top or into an inside pocket.
- For all products dyed in dark colours, a copy of an azo-free certificate is required for Conrad's files. If no such certificate is provided, Conrad will have the article tested by an institute authorised to do so at the Supplier's expense.
- As the Conrad group is represented in different countries, the label containing information regarding fabric composition and the relevant size, or product information if included with the goods in a printed version should be in the following languages:

Other languages already available:

The languages German, English, French, Dutch, Polish and Italian are obligatory unless otherwise agreed as a deviating provision of a Framework Agreement with Conrad.

3. Labelling gloves:

- For glove products with a "TÜV" label [German technical inspection association] / CE marking, a CE declaration of conformity or copy of the "TÜV" documents are required for Conrad's files.
- All certified glove products that are in line with DIN / EN standards must bear a label on the cuff showing the numbered standards and pictograms / CE markings, or must bear a product insert. In addition, if they are in cardboard packaging, this information should also be printed on the outside of this.
- For all products dyed in dark colours, a copy of an azo-free certificate is required for Conrad's files.
- In the case of textile gloves, glove sizes should be printed on the cuff or be easily recognisable in the form of a sewn-in size label; in the case of single-use gloves, sizes should be printed on the respective packaging board.



4. Labelling shoes:

- All certified shoe products that are in line with DIN / EN standards must be labelled with the numbered standards and pictograms / CE markings on the underside of the tongue. In addition, if they are in cardboard packaging, this information should also be printed on the outside or a product insert should be included in the box.
- The size is usually printed on the inside of the shoe. Furthermore, matching pairs are identified by identical numbers.

5. Packaging textiles / gloves /shoes:

- Every article must be packaged separately for delivery (plastic film or cardboard box) and sealed so that it is safe to dispatch.
- If the relevant size of the article is not visible, the size
- is to be attached to the packaging so that it is clearly legible.
- The sales packaging must be marked with GTIN code 13.

6. Operating instructions:

- If operating instructions are necessary for the article, these instructions must be included ex works.
- As the Conrad group is represented in different countries, the operating instructions should contain the following languages:
